





Fig. 8.1 shows part of a device for measuring the speed of alpha particles. All of the apparatus is in a vacuum.



Alpha particles emerge through a hole in the shield around the source and pass between a pair of flat, parallel electrodes. The bottom electrode is at 0 V.


- (a) The top electrode is at a positive potential V. On Fig. 8.1, sketch five lines to represent the electric field between the electrodes.




An iron core is wound with primary and secondary coils of insulated copper wire to make a transformer, as shown in Fig. 10.1.

- (a) On Fig. 10.1, sketch two complete loops of magnetic flux which pass through the secondary coil, when there is a current in the primary coil. [2]
- (b) The ends of the secondary coil are now connected to an oscilloscope to obtain the emf-time graph of Fig. 10.2.

On the axes of Fig. 10.2, sketch the variation with time of the magnetic flux in the secondary coil.

 - (i) Explain why eddy currents are set up in the core and suggest why this alters the flux in the core.



For 14 Examiner's Use 11 This question is about the scattering of a beam of protons from a thin target made of uranium metal. accelerating electrode proton detector $\theta = 10^{\circ}$ proton source uranium sheet proton beam Fig. 11.1 Fig. 11.1 shows some apparatus in a vacuum. A beam of protons is accelerated towards a thin sheet of uranium. Those protons which emerge deflected by an angle θ of 10° or less enter the detector and are counted. (a) The protons are accelerated to a speed of $1.5 \times 10^7 \,\mathrm{m\,s^{-1}}$ as they pass between the source and the accelerating electrode. (ii) Some of the protons are involved in head-on collisions with uranium nuclei in the target. By considering the energy transfers involved, show that the distance of closest approach of a 5.0 MeV proton to a uranium nucleus is about 3×10^{-14} m. A uranium nucleus contains 92 protons.
